COMMITTEE CHARGE

The Climate Action Committee aims to improve the sustainability of the built environment by promoting conservation of natural resources, design which brings buildings closer to net-zero usage, and public policy that supports these efforts. This diverse committee consists of individuals who also serve on the advocacy, education, communications or resilient design subcommittee.

OVERARCHING GOALS/OUTCOMES FOR 2023

- 1. Advance building decarbonization policies in California
- 2. Educate design professionals on ZNCD, sustainable design, and resilient design
- 3. Communicate and provide resources to design professionals on what they can do as individuals and within a firm to promote sustainable design and Climate Action in the built environment.

STATUS SUMMARY / RECOMMENDATIONS

9/18/23: Climate Action advocacy wins: the 2022 CEBC was updated by adding Chapters 6, 7, 8, 9, 10, 11 and 13 of the International Existing Building Code (IEBC), helping to ease barriers in the safe conversion of underused existing commercial buildings (AIA CA article here); and on 8/2/23 it was unanimously voted to bring our mandatory embodied carbon measures into CALGreen (AIA CA article here). The Climate Action Committee is currently looking forward for 2024 leadership and developing general 2024 work plan to continue to advance advocacy efforts at the local and state levels, and educate members and the public on the importance of our climate action work.
