PRIORITY ISSUES

The American Institute of Architects has taken bold steps to move the organization forward and address both environmental and social responsibility. How can the American Institute of Architects most effectively balance these major initiatives at the national level?

This is a great question. To **prioritise issues and identify solutions** a survey will be administered to AIA chapters including AIA International. Nonetheless AIA is actively addressing environmental and social responsibility **through integrating key initiatives at the national level**, ensuring a holistic approach to architecture:

- (i) Climate Action – Recognizing that buildings contribute to significant GHG emissions, AIA advocates for sustainable design practices, resilience and carbon-neutrality ([Their resources and tools help architects design for climate resilience and reduce carbon impact¹](#))
- (ii) Resilience – AIA promotes resilient buildings and communities ([Architects play a crucial role in designing environments that can withstand natural hazards and recover from adverse events²](#))
- (iii) Healthier Built Environments – focusing on designing spaces enabling healthier populations and lifestyles ([They emphasize research-backed strategies, materials selection, and community well-being¹](#))
- (iv) Equity – AIA is supporting architects to strive for excellence in providing equitable communities ([They aim for equitable communities and challenge architects to strive for excellence in this area¹](#))

Lastly AIA Framework for Design Excellence, through ten principles guides progress towards carbon-neutrality, resilient, healthy, just, and equitable built environment.

The American Institute of Architects (AIA) **plays a crucial role in supporting architects at different levels** to better serve clients and communities across the country:

At **National Level (AIA National)** AIA supports and empowers **Research and Advocacy** for policies that benefit the architectural profession and the built environment; **Continuing Education** for keeping architects informed about industry advancements, codes, and regulations; **Practice Resources** with tools, and guidelines for project management, contracts, and sustainable design; **Networking and Collaboration** for facilitating connections among architects, industry and policymakers.

At **State and Local Chapters (AIA State and Local)** AIA provides for **Community Engagement** to advocating for architecture's value; **Licensing and Regulation** for ensuring compliance and professional development; **Events and Programs** to fostering professional growth and community involvement; **Advocacy** for proactively engage in architecture-related policies.

Individual Architects are engaged in **Continuous Learning, Community Engagement, Mentoring, and Ethical Practice** ensuring integrity and client satisfaction.

To ensure a coordinated approach, the AIA provides support to its components (chapters and members) through the following measures: **Communication Channels** (newsletters, webinars, and conferences); **Best Practices Sharing; Collaborative Initiatives** (sustainability campaigns, equity programs, or disaster response efforts); **Resource Library** (the central repository of resources accessible to all components, i.e. design guidelines, research papers, and toolkits); **Leadership Training** (leadership development programs for component leaders); **Advocacy Support**; and **Collaborative Events** (national and regional events where components can network, exchange ideas, and collaborate on joint projects).
