SB 1048 (Jones) – Clean-Up Copyright Legislation

Clarified previous AIA CA legislation giving members of the public the right to view architectural drawings lodged onsite by planning departments and to review the documents online during a public have hearing on a project, but not to copy the documents without the permission of the copyright holder.

This victory ensures a more efficient planning process, reduces unnecessary project delays, and protects the integrity of architectural documents. SB 1048 not only protects the copyright interests of architects but also streamlines the review process for all stakeholders involved in planning and development.

AB 1862 (Chen) – Limited Liability Partnership (LLP) Extension

Extends the sunset on the law that allows architects, engineers, and land surveyors to form Limited Liability Partnerships (LLPs) by an additional eight years. Previously set to expire in 2025, this extension offers ongoing flexibility for architectural firms in their business structures.

Organizing as an LLP provides significant advantages, including limited liability protection and the benefit of pass-through income tax treatment, offering more options than a traditional corporation.

This legislation is vital for architecture firms, especially as the industry continues to evolve and adapt to changing market conditions.



Leading the way in reporting impact of embodied carbon in the built environment.

CALGreen Embodied Carbon Measures

First mandatory code in the United States to consider a buildings embodied carbon emissions.

AIA California was the primary driver of this effort, which included collaboration with dozens of other stakeholder organizations and individuals.

Effective July 1 2024, this was the culmination of a four-year effort.



Equipping architects with more code options for adaptive reuse.

Expansion of California's Existing Building Code to better support Commercial to Housing Conversion

It brings seven new chapters to the California Existing Building code, which will equip architects with more options when they work on reuse and retrofit of existing buildings.

Reuse and retrofit of existing buildings have been shown to yield greenhouse gas reduction benefits that can take 80 years to achieve with a high performing new building.



Leading input into ICC to facilitate office-to-housing conversations.

ICC Adaptive Reuse Working Group

AIA California launched this working group, looking for both near term code interpretation or code changes; as well as longer-term risk equivalency tools for design professionals to better facilitate challenging projects such as office-to-housing conversions.

Participation reflects the broad interest in this topic nationally as the group includes code officials from some of the largest cities in the country (New York, Chicago, LA, San Francisco, San Antonio, Tucson).



HCD Adaptive Reuse Working Group

AB529 required the California Department of Housing and Community Development to put a code working group together to find ways to lower barriers in the code for adaptive reuse of underused commercial buildings for housing.

AIA California has been very active; responding to the shifts and challenges and utilizing our member network to contribute with 35 separate code change recommendations to support adaptive reuse commercial to housing projects in California.

Legislative Select Committee on Permitting Reform

Liaison between AIA California code efforts and National's AIA Code Committee. This ongoing work will include the identification of strategies and tactics to leverage our efforts with support from AIA at all levels.

AIA California worked with local Chapters across the state to set up meetings with their California state senators and assembly members.

Though the meetings were, fundamentally, to establish relationships and develop understanding of the value of architects amongst elected officials and their staffs, Chapter members also discussed Climate Action and Housing issues, using data and talking points coordinated by AIA California advocacy staff.


